RESOLUTION NO. 5357

ENTITLED: "A RESOLUTION INCREASING THE LEVEL OF FUNDING PLACED INTO THE SOLID WASTE MANAGEMENT FUND FOR THE SPECIFIC PURPOSE OF PROVIDING FUNDING TO PAY FOR INCREASED PROFESSIONAL SERVICES COSTS AND SOLID WASTE TIPPING FEES, INCREASED RECYCLING COSTS, AND INCREASED COSTS FOR THE LEASE PURCHASE OF SOLID WASTE EQUIPMENT."

WHEREAS, a Solid Waste Management Special Revenue Fund was created by Resolution 3428 in September of 1993 to pay additional costs incurred due to R.C.R.A. Subtitle D and Wyoming Department of Environmental Quality (WDEQ) rules regarding solid waste disposal, and

WHEREAS, the Solid Waste Management Special Revenue Fund was expanded to cover costs of sanitation equipment replacement, recycling, landfill closure and groundwater monitoring, new landfill development, and landfill tipping fees, and

WHEREAS, additional appropriations to this fund were specified by Resolution 3845 in May of 1997, Resolution 4374 in October of 2002, Resolution 4695 in April of 2005, and Resolution 5214 in June 2010, for sanitation equipment replacement, recycling, landfill closure, groundwater monitoring, and new landfill development, and

WHEREAS, additional funding is required to pay increased costs of professional services and landfill tipping fees, and

WHEREAS, additional funding is required to pay increased lease/purchase costs associated with implementing automated sanitation collection and continue upgrade and replacement of Sanitation and Landfill equipment, and

WHEREAS, additional funding is required to pay increased costs associated with recycling programs,

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE, WYOMING;

That, the City Treasurer shall, beginning in July 2012 and from that time forward, make monthly deposits into the Solid Waste Management Fund as follows:

R.C.R.A. Subtitle D, WDEQ Compliance, and Disposal Cost Fund	\$167,500 (\$2,010,000 Annually)	TOTAL \$4,882,188
Recycling Fund	\$28,333 (\$339,996 Annually)	
New Solid Waste Disposal Facility and Landfill Closure Fund	\$94,183 (\$1,130,196 Annually)	
Vehicle and Equipment Replacement Fund	\$116,833 (\$1,401,996 Annually)	

BE IT FURTHER RESOLVED THAT all provisions of Resolutions 3428, 3845, 4374, 4695, and 5214 that are inconsistent with this resolution are hereby repealed.

ENTITLED: "A RESOLUTION INCREASING THE LEVEL OF FUNDING PLACED INTO THE SOLID WASTE MANAGEMENT FUND FOR THE SPECIFIC PURPOSE OF PROVIDING FUNDING TO PAY FOR SOLID WASTE TIPPING FEES, INCREASED RECYCLING COSTS, AND PAYING FOR THE LEASE PURCHASE OF SOLID WASTE EQUIPMENT."

WHEREAS, a Solid Waste Management Special Revenue Fund was created by Resolution 3428 in September of 1993 to pay additional costs incurred due to R.C.R.A. Subtitle D and Wyoming Department of Environmental Quality (WDEQ) rules regarding solid waste disposal, and


NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE, WYOMING;

ENTITLED: "A RESOLUTION INCREASING THE LEVEL OF FUNDING PLACED INTO THE SOLID WASTE MANAGEMENT FUND FOR THE SPECIFIC PURPOSE OF FUNDING A NEW SOLID WASTE DISPOSAL FACILITY, PROVIDING A DEDICATED FUNDING SOURCE FOR PAYMENT OF LOANS NECESSARY TO ACQUIRE A NEW SOLID WASTE DISPOSAL FACILITY, AND PAYING FOR THE LEASE PURCHASE OF SOLID WASTE EQUIPMENT."

WHEREAS, a Solid Waste Management Special Revenue Fund was created by Resolution 3428 in September of 1993 to pay additional costs incurred due to R.C.R.A. Subtitle D and Wyoming Department of Environmental Quality (WDEQ) rules regarding solid waste disposal, and

WHEREAS, appropriations for sanitation equipment replacement, recycling, landfill closure and groundwater monitoring, and new landfill development were added to this fund by Resolution 3845 in May of 1997, and Resolution 4374 in October of 2002, and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE, WYOMING;

That, the City Treasurer shall, beginning in July of 2005 and from that time forward, make monthly deposits into the Solid Waste Management Fund as follows:

R.C.R.A. Subtitle D and WDEQ Compliance Fund	\$75,000 (\$900,000 Annually)	
Recycling Fund	\$12,500 (\$150,000 Annually)	TOTAL
New Solid Waste Disposal Facility and Landfill Closure Fund	\$94,183 (\$1,130,196 Annually)	\$3,006,996
Vehicle and Equipment Replacement Fund	\$68,900 (\$826,800 Annually)	

And that funding placed into the New Solid Waste Disposal Facility and Landfill Closure Fund will be used exclusively for costs associated with obtaining a new solid waste disposal facility (to include payment of loans or bonds) and costs associated with landfill closure and reclamation.
